

VESPA DRAWING PARTICIPATION CONDITIONS:

The campaign covers the following terms and conditions, the participants are deemed to have accepted these conditions by participating in the campaign:

- The campaign will be valid between 20 May – 31 July 2021, and a total of 3 Vespa Primavera 50 model motors will be presented to the 3 winners with the National Lottery approved draw at the end of the campaign period.
- In order to participate in the campaign, the participants must upload the receipts of the purchases they will make at Emaar Square Mall stores between 20 May and 31 July 2022 through the Emaar Square Mobile application.
- The receipts/invoices uploaded by the participants will be examined by the Emaar staff, and the participant will be given the right to draw in proportion to the total invoice amount after determining their validity and adequacy.
